Subject: Results of the Selection of Candidates for the Position of English Teacher
“One District, One Quality School” Project, Semester 2, Academic Year 2025 (Round 2)

According to the announcement of the Chachoengsao Primary Educational Service Area Office 2 dated 12 December 2025, regarding the recruitment and selection of candidates for the English Teacher position under the “One District, One Quality School” Project for Semester 2 of the 2025 Academic Year (Round 2), the selection process was carried out through interviews on 7 January 2026.

The selection process now has been completed. The results of the selection are hereby announced as listed in the appendix of this announcement. The Chachoengsao Primary Educational Service Area Office 2 will use this announcement as the official notice of appointment. Selected candidates, in order of ranking, who will proceed with the employment agreement must report to choose their assigned school on 12 January 2026, between 08:30 a.m. to 09:00 a.m., at the Personnel Administration Group, Chachoengsao Primary Educational Service Area Office 2. They will begin their duties and sign the employment agreement at the selected school the same date. This list of selected candidates will remain valid for no more than two years from the date of this announcement. However, a candidate's placement on the list will be revoked, if any of the following circumstances occur:

1. The candidate has already been appointed.
2. The candidate voluntarily renounces the right to accept the appointment.
3. The candidate fails to report on the specified date, time, and location.
4. The candidate is unable to perform the duties within the specified period.
5. The validity period of the selection list has expired.
6. If the verification process reveals any discrepancies or a lack of required qualifications, the appointment will immediately be revoked and the candidate will have no right to claim any entitlement. Candidates are required to present the following documents and supporting evidence upon reporting:
 1. A copy of the valid national identification card, with the original. (2 sets.)
 2. A copy of the house registration, with the original. (2 sets.)
 3. A copy of the degree certificate or qualification certificate, and the academic transcript, with the originals. (2 sets.)

4. A copy of the teaching license issued under the Teachers and Educational Personnel Council Act B.E. 2546, or other valid documents issued by the Teachers Council permitting the teaching duties, with the originals. (2 sets.)

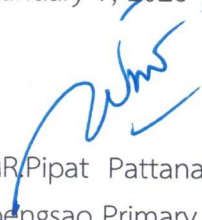
5. Other relevant documents (if any), such as a marriage certificate, a certificate of name or surname change, or a military service selection certificate (Sor Dor 8 or Sor Dor 43). (2 sets.)

(All copies must be certified as true copies and signed on each document.)

If it is subsequently found that a selected candidate does not meet the qualifications specified in the recruitment announcement or those established by the Office of the Basic Education Commission, the selection of that candidate will be immediately revoked. If any documents or evidence submitted are found to be false, the candidate will be considered ineligible and will not be allowed to enter into an employment agreement. If the employment agreement has already been executed, it will be terminated, without any entitlement to claim compensation.

Therefore, this announcement is hereby promulgated for public information.
